DELEGATION

Brenda Pyne had accepted an invitation from the Arts & Heritage Committee to attend this meeting and introduce their organization. The Taber & District Impact Irrigation Museum is an interpretive centre and museum and holds Taber & District's archives. They were initially started in October 1985 as a non-profit and are a Canadian Registered Charity. Brenda prepared a presentation for the Arts & Heritage Committee on some of the history of Taber, which included artifacts of Taber and District history, information on how the Museum obtained these items as well as their relevance to Taber and the surrounding areas.

The Taber & District Museum requested the Arts & Heritage Committee's support in obtaining the Taber Chamber building once the Chamber has found their new home. The Chamber's old building would be a great addition to the Museum as it would allow the museum access to more storage and they would also be able to utilize the space for a semi-permanent exhibit as they change their exhibits 2-3 times a year.

Background:

- October's Gord Bamford Concert has been postponed due to Covid restrictions. It will now be held on March 19th 2022.
- The Halloween Howl was a success. We had approximately 300 kids go through the Covidfriendly event this year.
- 3. The Veteran banner project is near completion for the first year. It was very successful with a sold-out first year with selling a total of 70 banners. We already have people on the waiting list for next year and are working on purchasing more brackets to have more than 70 banners. The banners come down on November 18th when the Christmas lights go up.
- 4. Taber and District Adult Learning Association held their "Door to the World" Multi-cultural gala at the Community Centre on November 4th. It was a success with no incidents.
- 5. Remembrance Day Ceremony was changed to an invite-only event that live-streamed their service.
- 6. November 19th is the annual Winter Festival put on by the Taber Chamber of Commerce partnered with the Town of Taber. It will be similar to last year with covid-friendly activities such as "social distanced Santa pictures", hay rides, free skating sponsored by the Kinsmen, free swimming sponsored by Taber home and Farm, the Library's Jingle Craft sale beginning that night, tree-lighting ceremony, and a few extra things that will be announced that night!
- 7. December 4th is the Town of Taber's annual Christmas Farmers Market. We've started accepting applications and so far have 16 vendors.



- 8. Emily returned to her position as the Art, Culture and Event Coordinator as of October 15th following her maternity leave. Amy is now in the Planning Department as the Economic Development Officer.
- 9. We are looking to offer PD Day Drop-in Programming for kids, similar to our evening drop-in programs. Self-supervised sports and activities.
- 10. We are looking at new ideas for our evening drop-in programming for the new year and for new ways of getting the community involved.
- 11. Focus Group: we will discuss this with the new manager/ director and bring it back to the Arts & Heritage Committee following direction.
