## BY-LAW 12-99 FOIP

BEING A BY-LAW OF THE TOWN OF TABER, IN THE PROVINCE OF ALBERTA, TO REGULATE THE FREEDOM OF INFORMATION AND PROTECTION OF PRIVACY.

WHEREAS pursuant to section 89 of the *Freedom of Information and Protection of Privacy Act*, S.A. 1994, c.F. –18.5, and amendments thereto the Town of Taber must designate a person or group of persons as the head of the Municipality for the purposes of the act;

AND WHEREAS, it is recognized that the Taber Municipal Police Commission, will by resolution, appoint a person as head for the purposes of the Freedom of Information and Protection of Privacy Act;

AND WHEREAS, pursuant to Section 87 and 89 of the *Freedom of Information and Protection of Privacy Act*, the Town of Taber may set any fees payable to the Town for services under the *Act* and Regulations:

## PART I - PURPOSE, DEFINITIONS AND INTERPRETATIONS

**PURPOSE** 

The purpose of the Bylaw is to establish the administrative structure of the Town of Taber in relation to the *Freedom of Information and Protection of Privacy Act*, and to set fees thereunder.

DEFINITIONS

In this Bylaw unless the context otherwise requires: "ACT" means the Freedom of Information and Protection of Privacy Act, S.A. 1994, c.F-18.5;

"Applicant" means a person who makes a request for access to a record under section 7(1) of the Act;

"Municipality" means the Town of Taber and includes any board, committee, commission (excluding the Police Commission), panel, agency or corporation that is created or owned by the Town of Taber and all the members or officers of which are appointed or chosen by the Town of Taber.

"Town Manager" means the person appointed as the Chief Administrative Officer of the Town of Taber, and includes any person who holds the position of Town Manager in an Acting capacity;

"Province" means the Province of Alberta.
