## A) Cowboy Poetry

Mr. David Woodruff was present to let the Committee know that there is an interested group working on bringing back Cowboy Poetry and Western Music event back to Taber in March. The history of the event is that it used to be a fundraiser put on by the Taber Museum, however they were not able to make money on the event and discontinued.

The group has approached some teachers who are willing to have the students involved, local talent, and some veteran performers have been invited. They plan to have the event at the Community Centre and hope to have the fee waivered. The group is actively fundraising getting sponsors/donors (which they have received a generous amount from the MD of Taber) and will be charging at the door with the funds going to pay the performers. They are also presenting at the next Town of Taber Council Meeting with the information and to ask for the facility waiver.

The group only plans to have this one event annually, therefore do not want to get their society status and wish to find a partnership with an existing group who can look after the funds. The Members made a few suggestions and suggested they contact the STAR Theatre, as this seems like a perfect fit.

The Committee thanked the delegation for their presentation and asked them to keep in touch.

The Members and Administration recognized Jeff Bronsch's last meeting with the Committee and thanked him for his time and talent he has extended over the last three years.


