DELEGATIONS

A) Ben Tams

Ben Tams was on hand to present and answer questions about his plans to bid for a HJHL team for Taber. He was hoping to get the Recreation Board's support. If approved for a team, he is hoping to play all or at least half of the team's 21 home games in Taber (September-February) and plans to practice in Vauxhall as he prefers to not put out other users during the week. Administration reported that there is time for most or all games to be played in Taber, but this would mean adjusting a few start/end times for a few

users. With this league scheduling its season in the spring/summer, it should be fairly easy to manipulate the ice schedule to accommodate the additional team. If approved the ice usage from Taber/Vauxhall, B. Tams reported his next step would be to present his proposal to the League's Board in April.

The Board Members were excited for the idea of a Jr Hockey team once again calling Taber home and appreciated all the work Mr. Tams and his associates have put into this initiative and wished him luck.
