## Chief of Police Report to the Commission

Chief G. Abela shared details from his report and provided more information regarding ammendments to the Controlled Drugs and Substances Act and the Prosectors Handbook.

He was notified that recent charges for possession had been withdrawn which lead to some inquiries. In recent meetings with the Federal Prosector it was made clear that there will be no chares laid for possession of drugs (except in cases with extenuating circumstances) and that a shift is being made to view these offences as social and health issue rather than criminal. There have also been recent meetings with the Alberta Chief's of Police to further discuss these changes. Chief, G. Abela expressed his concerns and noted with these changes to the prosecution of drug possession may no longer achievable in the community.

Chair J. MaDonald suggested that Commission review all of the related materials regarding these changes and they continue to have discussion on how to move forward on this issue.
