CALL TO ORDER

Brian Martin called the Regular Meeting of the Taber Recreation Board to order at 5:30 PM.

Being as there were no further nominations, Darcy Firth was declared elected Chair of the Taber Recreation Board.

B. Martin called for nominations from the floor for the position of Vice Chair of the Taber Recreation Board.

Darcy Firth nominated Brett McCoy for the position of Vice Chair of the Taber Recreation Board.

ACTION ITEMS

BYLAW 2-2009 RECREATION BOARD BYLAW

Councillor Jack Brewin arrived @ 5:44 PM

Administration has brought the Recreation Bylaw to the Board for review as it has been years since its previous revisions.

The Members discussed the wording regarding the MD of Taber representatives on the Board having to be "from divisions 1-4 (South of the Oldman River)" is restrictive and may no longer be necessary.

I was also discussed that it may be advantageous to have the MD of Taber and the Town of Taber Councils appoint alternates to the Board to assist in making quorum.

The frequency of meetings was also discussed. While some members thought quarterly may be often enough to meet, others thought it was too long between meetings when users come forward with requests, concerns, or suggestions. It was also thought that maybe leaving it at 9 meeting/year with more flexible language for less, if the Chairperson and one other Member agrees to cancel a meeting would be better for productivity of the Board.

RES. 03/2024 MOVED by B. McCoy that the Recreation Board recommends Council accepts the proposed changes to the Bylaw 2-2009 Recreation Board Bylaw, as follows:

• <u>DELETE</u> 3.0 COMPOSITION OF THE BOARD

The Recreation Board shall consist of the following seven (7) voting members appointed by the Council of the Town of Taber:

Two (2) Town of Taber Councillors

Four (4) residents of the Town of Taber; or three (3) residents of the Town of Taber and one (1) resident of the MD of Taber-from divisions 1-4 (South of the Oldman River), One (1) M.D. of Taber Councillor from divisions 1-4 (south of Oldman River)

ADD

3.01 An alternate member of Council (from both the Town of Taber and the Municipal District of Taber) may be appointed.

ADD

5.7The Board shall should hold no less than nine (9) regular meetings each year, with the Chairperson's (along with one (1) other member) discretion to cancel or alter meeting dates and it may hold special meetings at the call of the Chairperson, or any three (3) members upon 24 hours notice.

INFORMATION FOR THE RECREATION BOARD

The Members reviewed the items presented and were given the opportunity to ask for any of these topics to be expanded on or to discuss any other topic of interest.

The Members reviewed all items in this agenda item, line by line.

The arena grant was declined and Administration reported that smaller projects are being planned and the town is looking at some different grants. There is a brine leak which will need to be addressed in the off season.

Some additional notes were made:

- 13. Department and Engineers are looking at resurfacing the skatepark's surface (formally the brick filled area). Users were picking out the brick and putting them in the "Red Bucket" at the spraypark. Brick has been removed, just looking for an affordable solution. It was suggested that the Red Bucket have a mesh installed for safety.
- 14. Tennis court is finally in the cue to be resurfaced after 2 years in Capital budget, which was due to contractor delays.
- RES. 04/2024 MOVED by Councillor J. Brewin that the Recreation Board recommends to Council that the new urban park to be named "Tank 77".

CARRIED UNANIMOUSLY

- B. Martin also updated the Board on the next steps for the Trout Pond, since the Master Plan has been approved. The Landscape Plan is next and hopefully the park will have many new trees this spring. The Members of the Board discussed the functionality of the Taber Trout Pond Committee and questioned why the Recreation Board is not part of the collaborations/decisions. They did acknowledge and appreciate that they did get updates from Administration throughout the process, however believed they should be more involved as the Taber Trout Pond is a recreation facility which falls under the Recreation Board's advisory mandate.
- RES. 05/2024 MOVED by C. Fletcher that the Recreation Board recommends to Council to consider having the Taber Trout Pond Committee come under the oversite of the Taber Recreation Board.

Wendy Einwechter, from the Taber Adventure Club, was at the meeting to update the Board on how the Club is doing and its future plans. They currently have 23 members who are 5-18 years of age. The Members thanked W. Einwechter for her presentation and wished the club luck.

Hello Taber Minor Baseball is requesting to come to a recreation board meeting to discuss this years diamond usage and maintenance. The diamonds have been in rough shape the last few years and we at TMB would like to know where we can help and what the town can do to help get the diamonds into better shape and continued care.

Our asks are as follows.

- 1. We would like to get the netting on the batting cage fixed and hung properly.
- 2. We would like the shale in the batting cage leveled off and a batting mat placed at the west end to help with batters making ruts.
- 3. Look at an option for a pully system to lift the netting on the east end so that it is easier to get pitching machines in and out of the batting cage.

Diamond maintenance:

We know that this is time consuming and the town has many other parks and fields it needs to maintain. We would like to open up some dialog on how we can help with this.

Examples are we can help do some raking and dragging if tools are left where we can get to them. We can help clean out garbage cans in the dug outs and put in the big dumpster if we had access to more garbage bags to put back in the bin.

We are open to any other discussion with the Recreation Board and town staff on any other topics that come up as further discussion goes forward.
