#### **BYLAWS**

# A) Proposed Restrictive Vehicle Idling Bylaw 1-2011 – 1<sup>st</sup> Reading

G. Frank, CLGM, Chief Administrative Officer, presented the proposed bylaw prepared by Administration. In the creation of the proposed bylaw, consideration of three municipalities that presently have an idling bylaw, as well as municipalities that have policies instead of bylaws, occurred.

## B) Municipal Library Board Bylaw 3-2006 – Board Composition

A request to amend the Municipal Library Board composition, Section 3.1, was presented at the November 8, 2010 Regular Meeting of Council, wherein Council passed the following resolution:

- G. Frank, CLGM, Chief Administrative Officer, summarized various board composition models that Administration has investigated throughout other municipalities.
- RES.136/11 MOVED by Councillor Rochelle that the Taber Library Board shall consist of eight members:
  - a) Six (6) members of which shall be appointed by Council from Citizens-at-Large from more than one municipality.
  - b) One (1) member shall be appointed from the Council of the Town of Taber.
  - c) One (1) member shall be appointed from the Council of the Municipal District of Taber.

Council discussed the merits of various board compositions at this time.

- B) Municipal Library Board Bylaw 3-2006 Board Composition Cont'd
- RES.137/11 MOVED by Councillor Bekkering that the Taber Library Board shall consist of eight members:
  - a) Six (6) members of which shall be appointed by Council from Citizens-at-Large, two (2) of which may be residents of the Municipal District of Taber.
  - b) One (1) member shall be appointed from the Council of the Town of Taber.
  - c) One (1) member shall be appointed from the Council of the Municipal District of Taber.
