# i) Explanation of purpose of Bylaw No. 6-2015 - Cont'd

C. Armfelt advised the purpose of draft Bylaw 6-2015, if approved, would be for rezoning of 4 lots which are currently zoned as Limited Institutional/Recreation (L-IR) and General Industrial (M-2) to Highway Industrial (M-4). The lots to be rezoned are 6216 60<sup>th</sup> Street; Lot 31 Block 27 Plan 8210712, 6210 60<sup>th</sup> Street; Lot 32 Block 27 Plan 8210712, 6204 60<sup>th</sup> Street; Lot 33 Block 27 Plan 8210712, and a portion of Lot 29 Block 27 Plan 8210712, in accordance with Section 692(1) (f) of the *Municipal Government Act*, Chapter M-26, Revised Statues of Alberta 2000, as amended.

The reason for the rezoning is that on August 18, 2014, Council made a resolution to sell a portion of a Town-owned parcel (Lot 29 Block 27 Plan 8210712) to B & H Tank Systems Inc. One of the conditions of the land sale was the Town of Taber would rezone the portion of the parcel to be subdivided at the Town's expense. The subdivision of the parcel also includes the consolidation of the adjacent parcels owned by B & H Tank Systems Inc., thus the reason for the rezoning of the other 3 lots.
