CALL TO ORDER

Mayor De Vlieger called the Regular Meeting of Council to Order at 5:45 PM.

BYLAWS

A) Bylaw 11-2015 1st Reading

C. Armfelt stated that on May 11, 2015 Council passed a motion to direct Administration to prepare a draft bylaw to amend Land Use Bylaw No. 4-2006 in order to create a Direct Control district. The district will contain approximately 10 ha (25 acres) in area at the northern corner of NW 8-10-16-4 and NE 8-10-16-4, immediately south of 80th Avenue, in order to accommodate composting, recycling, and associated waste handling facilities.

A) Bylaw 11-2015 1st Reading - Cont'd

Council discussed the resident concerns, design, and condition of the property.

Councillor Brewin requested a friendly amendment to add rock garden to the motion.

Councillor Sparks declined the friendly amendment.

A) Old Rodeo Grounds Dry Pond Rehabilitation - Cont'd

B) Taber Exhibition Association: Bylaw Enforcement Request

G. Birch stated that correspondence was received from Taber Exhibition Association (TEA) detailing an ongoing situation of concern for the organization. The TEA is requesting that bylaw enforce Heavy Metal Demolition or Spitfire Investments to clean up and remove the green plastic bags and repair the fence between properties to the previous condition.

Constable Gyepesi, representing the Taber Police Service provided additional information in regards to the previous occasions of contact and details of enforcement relating to this matter.

C) 52nd Avenue Tender Award

G. Scherer stated that at the January 12, 2015 Council meeting Council determined their preferences for capital projects, in 2015, was 50th Street road rebuild and 52nd Avenue Water Renewal. 52nd Avenue tender opened on April 23, 2015 and closed 2:00 p.m. May 14, 2015.

MOVED by Councillor Sparks that Council awards the 52nd Avenue Water Renewal Tender to Ground Tech Enterprises for the amount of \$1,082,998.13 with additional funds to be allocated from the Town's capital reserves in the amount of \$500,738.83.

D) Arena Dressing Rooms Addition - RFP Recommendation

A. Holmen stated that Council's 2015 capital budget includes development of new dressing rooms at Taber's Community Centre ice arena. The project includes 2 players' dressing rooms, a referee dressing room and washrooms and showers to service the new players' and referee dressing rooms.

The Town issued a Request for Proposal earlier this year that closed on April 1, 2015. Council rejected all of the proposals reviewed on April 13, 2015 (RES.202/2015). Therefore, a second Request for Proposals (RFP) package was developed in April.

Council discussed the results of the proposals received for this project.

MOVED by Councillor Brewin that Council awards the Arena Dressing Room Addition to Venture Holdings Ltd for the stipulated price of \$439,700.00.

E) Taber Rodeo Association Lease

G. Birch stated that the Taber Rodeo Association is hosting an event for the 2015 Wish Ride Committee on the grounds that are leased from the Town for a function in August. In email communication received, the Association states that since it isn't able to help with a cash donation, they are able to be part of the function by donating the use of the grounds.

In accordance with the current lease between the Town of Taber and the Taber Rodeo Association (signed November 2012), Section 7 states that:

"The Lessee acknowledges that it is not an agent for the Town and shall not enter into any agreements regarding long term or present use of the land other than for the purpose and term of this agreement."

Council discussed the stipulations of the lease.

RES.262/2015

MOVED by Councillor Sparks that in accordance with the current lease between the Town of Taber and the Taber Rodeo Association, Section 7, Council:

 Authorizes the 2015 Wish Ride Committee the use of the lands currently leased to the Taber Rodeo Association described as portion of NE ¼ 1-10-17-W4M for the 2015 Wish Ride event taking place August 21-23, 2015;

E) Taber Rodeo Association Lease - Cont'd

- Stipulates that the Taber Rodeo Association shall complete and submit a Special Event Application for this event to the Town's Director of Recreation for this event;
- 3) Stipulates that the Taber Rodeo Association shall ensure that all concerns or conditions of the Special Event Application are complied with to the satisfaction of the Director of Recreation and the Chief of Emergency Services;
- Stipulates that all other terms and conditions of the existing lease to the Taber Rodeo Association remain unchanged; and
- Requests that Administration invite the Taber Rodeo Association group to meet and discuss the terms of the existing lease.

F) 2015 Taber Wish Ride Committee: Request for Use of Town Logo

G. Birch stated that a request was received from the 2015 Taber Wish Ride Committee to use the Town of Taber logo on a fire ring that is being constructed as an auction item for the group's event being held August 21-23, 2015 to commemorate this event. Since the Town logo has been copyrighted, authorization to use the logo is required by Council.

MOVED by Councillor Popadynetz that Council authorizes the 2015 Taber Wish Ride Committee use of the Town of Taber logo for utilization on a fire ring for the 2015 Wish Ride.

G) Utility Bill Adjustment

D. Weiss stated that in April of 2015, when processing the meter reads, the utilities clerk noticed that a commercial property (utility account number 114200.000) had an unusually large consumption of water. The utilities clerk called the property owner to inform them of the large consumption amount and therefore a large utility bill in the amount of \$2,234.14. The property owner said the large consumption of water was due to a burst irrigation line. After receiving the utility bill, the property owner sent correspondence requesting a reduction to the amount of the sewage consumption fee which is based on water usage.

That work culminated at the April 13, 2015 Council meeting, when a draft Whistleblower Policy and Whistleblower Procedure were provided to Council for consideration. Council discussed those drafts and, in particular, the inclusion of MNP LLP in more stages of the process than suggested in the two draft documents.

MOVED by Councillor Strojwas that Council approves the Whistleblower Policy and Procedure ADM-6 with amendments to establish that MNP LLP shall be the first point of contact for anyone making a complaint or expressing a concern, and to reflect replacing Human Resource Manager with Administrative Services Manager in Sections 1), 2) and 6) in the Procedure Operating Guidelines.
