ACTION ITEMS

A) Arena Dressing Room Addition

Mayor De Vlieger declared a pecuniary interest in this Agenda item, turned the meeting over to Deputy Mayor Strojwas, and left the meeting at 5:00 PM.

G. Scherer introduced A. Holmen and T. Smith who described that at the May 25, 2015 meeting, Council awarded the Arena Dressing Room Addition construction contract to Venture Holdings Ltd for the stipulated price of \$439,700.

A. Holmen stated that the construction contract has been delivered to Venture Holdings Ltd for a signature. In discussion with their representative, Administration enquired as to the process going forward should there be a request to change the design of the addition to include two referee change rooms as opposed to the current design of one referee change room.

The process would include:

- Signing the current contract
- Completing a contemplated change order for the project asking to amend the current design
- Venture Holdings Ltd would then provide a price and a design for the contemplated change

ACTION ITEMS - CONT'D

A) Arena Dressing Room Addition - Cont'd

 Venture Holdings Ltd would then need to have the updated design and price approved by the Town prior to proceeding.

During the first Request for Proposals that was completed in April, Venture Holdings Ltd did submit a detailed design that included two referee rooms. The cost for the design with the two referee rooms was \$475,000 which exceeded the budgeted allotment of \$450,000 for the project. In the second Request for Proposal, the bid document was amended by the Town in order to keep the project within budget.

G. Scherer stated that should Council determine that they would like Administration to complete a Change Order for this project to include the second referee room; the cost would be approximately \$35,300 as estimated by a Venture Holdings representative. This is the difference between the two proposals presented by Venture Holdings Ltd in each Request for Proposals (\$439,700 to \$475,000).

Council discussed the design plans supplied by the contractor, the referee user group viewpoints, and the budget implications.

MOVED by Councillor Popadynetz that Council:

- a) Proceeds with the contract as previously awarded on the basis that the cost of a second referee change room is high relative to the demand for two referee change rooms.
- b) Allocates a 15% contingency to the Arena Dressing Room project.

Councillor Sparks requested a friendly amendment to specify the request for a change order for the second referee change room.

Councillor Popadynetz accepted the friendly amendment.

Council discussed the motion further.


