LAND USE AMENDMENT BYLAW NO. 13-2015

i) Explanation of Purpose of Bylaw 13-2015

C. Armfelt stated that on August 17, 2015, Council passed 1st Reading of Bylaw 13-2015. The proposed Bylaw will repeal Bylaw A-338, the Eureka Industrial Park Area Structure Plan. The Are Structure Plan was created in 1994 and due to the many changes over the years, the Are Structure Plan has become inconsistent with the current industrial development.
