# C) Fire Department Response Times

G. Birch reviewed the current Taber Fire Department Response Times. Chief Munshaw stated that the Alberta Building code in 2006 addressed high density residential fires. This identifies a fire department's need to respond in under 10 minutes, more than 90% of the time. Towns with fire departments unable to achieve this within their response areas would then require new buildings sprinkler systems installed or increase set backs from property lines. Chief Munshaw stated that funding from the Operating Budget could be allocated to hire a third party to provide a Response Time Study prior to December 31, 2015.
