Council also requested Administration to explore all grant opportunities for this project.

Mr. Armfelt stated that the proposed bylaw would rezone the property from Low Density Residential (LR-2) to Medium Density Residential (MDR) and would facilitate the development of a 4 unit Row House.

The Recreation Board has now viewed the draft Recreation Master Plan and the user group was invited for discussions at their March 3, 2016 Recreation Board meeting. From those discussions the Recreation Board passed the following motion:
