A) Update on Regional MRF Facility

C. Armfelt provided an update on the Regional Materials Recycling Facility (MRF). Mr. Armfelt reported that Administration is currently appealing for support to municipalities in Southern Alberta prior to applying for the Alberta Community Partnership Grant. Mr. Armfelt stated that Administration is recommending that Council supports the hiring of a person to gather preliminary data.

D) Downtown Street Light Replacement

Mr. Birch stated that during 2016 budget deliberations, Council considered a proposal to replace the downtown cobra-head style streetlights with decorative LED lights that would match the new lights used on the corners where downtown beautification has already occurred.

Mr. Birch stated that the Town of Taber receives annual franchise fees from ATCO Gas and Fortis Alberta, and has thereby assigned 7.5% of that annual fee revenue to be put towards the reduction of energy consumption in Town owned buildings.

Council discussed the Committee's proposal to replace existing lights at Town owned facilities.
