A) Proposed Municipal Development Plan Bylaw 7-2016 2nd Reading

Council discussed the proposed Municipal Development Plan and its adopting Bylaw 7-2016 and information provided at the Public Hearing.

MOVED by Councillor Popadynetz That Council gives 2nd Reading to Bylaw 7-2016, a bylaw to adopt the Municipal Development Plan, with the Plan being amended by the following changes:

Section 3.6.4 (b): The approved Northwest Area Structure Plan shall be rescinded and an updated Area Structure Plan prepared for lands within the northwest Residential Area prior to the subdivision and development of those lands. An Area Structure Plan shall address the proposed land use and transportation systems, utility servicing, phasing, irrigation, existing easements and right-of-ways, municipal reserve and open spaces including a range of parks types and sizes.

Section 3.8.2 Industrial Policies the addition of:
m) Low Impact Development (LID) techniques are
encouraged. New developments in the Industrial
Area should minimize development of
impermeable hard surfaces such as driveways. New
stormwater management facilities shall consider the
use of low impact development techniques and
bioswales.

Section 3.9.2 Policies the addition of:

- I) Taber Irrigation District irrigation water should be used prior to the use of treated water when irrigating parks or for make-up water in storm ponds.
- m) The Trout Pond west of Taber (on Town owned land in the Municipal District of Taber) will be a focus as a recreational development node.

A) Proposed Municipal Development Plan Bylaw 7-2016 2nd Reading – Cont'd

- n) The Town should integrate protected easements and right-of-ways where they exist into parks and green spaces whenever possible.
- o) Priorities outlined in the Recreation Master Plan should be considered when planning for new recreation and open space opportunities.

Section 4.1.2 Policies the addition of:

f) Minimize conflicts with existing Taber Irrigation District easements and right-of-ways.

Section 4.2.2 Policies

- g) Development in all areas should only be approved in conformity with the infrastructure recommendations contained in the Town of Taber Stormwater Master Plan (MPE Engineering, August 2015).
- k) The Town will pursue measures to ensure retention, treatment, and controlled release of stormwater entering Taber Lake.

All maps are to be amended to include the following:

- Taber Irrigation District easements and rightof-ways
- 69th Avenue and the industrial intersection at highway 36

Map 3 will be amended by the following:

 Parcels currently designated as residential along 62nd Avenue between 50th and 56th Street will remain residential, as per the current Land Use Bylaw

- Wind Energy Conversion Systems (WESC) means the complete system required to convert wind energy into mechanical or electrical energy.
- Solar Energy Collector Systems (SECS)
 means the complete system required to
 convert solar rays into useable electricity for
 private use, including solar panels, mounting
 equipment and additional required conversion
 electronics.

Section 2.6.4(2) the removal of "full motion video, animation or" to read as Digital Media content must not include flashing images. In case of an electronic message board, the text may scroll at a pace deemed acceptable to the Development Authority.

Section 2.6.16(2) the removal of: (d) Portable Signs may not contain Digital Media or be fitted with any flasher, animation or revolving beacon, and all letter points should be updated to reflect the deletion of part (d).

Section 2.6.16(2) (e) changed to (d) A Portable Sign must be at least 45 m from a Residential District, 45 m from any other portable sign, and at least 0.6 m from a property line.

Section 2.6.16(2) (i) changed to (h) A development permit application for a portable sign to be located on Town-owned land:

 Shall only be considered by the MPC if a lease or license has been previously approved by Council.

May be approved in any Land Use District.

Section 2.6.16(2) (o) changed to (n) A portable sign on private land that is for a community event and will be removed within 14 days of its placement shall:

- Require a development permit,
- ii. Not require the submission of a fee for that permit, and
- Be approvable by a Development Officer.


The addition of Food Trucks to Part 3.1 Accessory Uses and the updating of numbering in Part 3.1 to reflect the addition.

3.1.x Food Trucks

- (1) Food Trucks shall only be permitted in the Downtown and Central Commercial Districts as per this Land Use Bylaw.
- (2) Upon passing this bylaw, all existing and forth coming food trucks will require a development permit.
- (3) Food trucks shall not be located on Town-owned property without prior written consent from the Chief Administrative Officer based on conditions under a duly executed Development Permit.
- (4) Food Trucks shall not be located where they create a hazard to the public as determined by a Development Officer, Bylaw Officer, Law Enforcement Officer, or the Director of Planning and Economic Development.

Section 3.1.2(5)(a) changed to: 0.6 m from exterior side wall or rear property line not shared with a street if the Accessory Use has less than a 10.0 m² gross floor area;

Section 4.8.2(4) the addition of: Food Trucks.

Section 4.9.2(4) the addition of: Food Trucks.

Section 4.12.1 changed to: The district provides for the existing food processing plant (sugar plant), which is considered to be a high impact industrial use within the Town with nuisance factors that have the potential to extend beyond the boundaries of the site. Other similar industrial facilities will also be contemplated under this district.

Section 4.12.2 (4) the addition of: Wind Energy Conversion Systems and Solar Energy Conversion Systems.

G. Armfelt provided information on the request for Subdivision extension received by the Town of Taber. Mr. Armfelt explained that circumstances regarding this subdivision have been affected by a change in ownership and by challenges with servicing the lot. Mr. Armfelt reported that the Municipal Government Act, Section 657(1) (6) states that Council may extend the one-year period referred to in subsection (5), whether or not the time period under those subsections has expired.

G. Scherer introduced M. Harker of MPE Engineering who provided a review of the Potable Water Distribution Master Plan.

E) EPCOR Operations Agreement Proposal

- G. Birch presented background on the EPCOR Operations agreement proposal. Mr. Birch stated that Town Council has been meeting with EPCOR representatives since November 9, 2015. He described options available to Council regarding the EPCOR Operations agreement.
- G. Scherer who provided further background on the history with the Town of Taber and EPCOR Operations relationship.

Administration recommended the Town of Taber conduct a study to verify and substantiate numbers and determine the best options for the Town.

RES.316/2016 MOVED by Councillor Sparks that Council:

a) directs administration to evaluate the three options available to the Town of Taber for future operation and maintenance of the Town's water, wastewater and storm sewer systems given EPCOR's request that annual fees be dramatically increased if EPCOR is to continue to provide service;

and.

b) directs administration to contract MPE Engineering for the development of a water and wastewater operation study to help with this evaluation, with an upset cost of \$17,500 funded from Operating Reserves.

F) Residential Solid Waste, Recycling and Organics Update

G. Scherer presented an update on Taber's residential solid waste, recycling and organics program. Mr. Scherer stated that he was cautiously optimistic about the progress of this new program in that the data reflected only a month's activity, but that there has been a significant diversion of waste into the composting stream and an increase in recycling as a result of the new cart program.

Mr. Scherer reported that education is still a high priority and that this new program intends to be visible at the Taber Cornfest event.

Council discussed the success of the solid waste, recycling and organics program to date.

G) Windscreen Fencing for the Recycling Drop Off Area

G. Scherer described the need for windscreen fencing for the recycling drop off area located between the Taber Police Service and the Taber Home Hardware property due to westerly winds.



Danielle Larivee, stating that it endorses the resolutions of the Alberta Fire Chief Association requesting that the Alberta Government establish a provincial fire act and minimum training standards for municipal services, and that this letter be copied to AUMA and AAMD&C and that Administration undertake to put this proposal to the AUMA as soon as possible.

Councillor Ross-Giroux offered a friendly amendment that Council gather support for this resolution from other municipalities.

Councillor Popadynetz declined the friendly amendment.

Ltd. properties prior to the trade.
- 3. Construction of a proposed salvage yard at Block A1, Plan 7819AQ must be undertaken based on current industry best management practices,
- 4. Buffering around any future salvage yard on Block A1, Plan 7819AQ must be completed and be included as part of the future development planning for the parcel.
- 5. South Alta Trading Co. Ltd. will connect 56th street to its development area and will utilize this access for the primary egress to the proposed future salvage yard or any other similar development. Additionally, any lots sold along this road will pay a frontage fee based on the proportionate cost of construction by South Alta Trading Co. Ltd. as recovery for South Alta Trading Co. Ltd. fronting the costs for said road construction,
- 6. South Alta Trading Co. Ltd. will be responsible for the cost of all improvements of roads built within its 33 acre parcel.
- 7. South Alta Trading Co. Ltd. will be responsible for mitigating the concerns of Lantic Inc. due to the development of this parcel given the fact that Lantic Inc.'s effluent line runs through this parcel,

8. The Town of Taber will retain water rights located on Block A1, Plan 7819AQ subsequent to the sale, but will lease these water rights back to South Alta Trading Co. Ltd. for a period of seven (7) years.
