Birch introduced Sherry Crombez, President, and Frank Kast, Vice President representing the Taber Exhibition Association who described the project proposed by the Association requesting that Council consider the tinning and strapping of the exterior walls of the Agriplex building premises owned by the Town of Taber located at Plan 8410163, Block 1, Lot 1; civic address of 6602 53 Street, Taber, AB, by the Lessee, the Taber Exhibition Association.

Mr. Birch explained that in accordance with the current lease, Section 5, any improvements to the premises contemplated by the Lessee must be approved in advance written notice by the Town prior to improvements being initiated.

Councillor Popadynetz left the meeting at 6:08 PM.

Council discussed the communication between Lessee and Lessor, costing strategies, and the identified project requirements.

At the price of \$25,000/Acre.
- C. Armfelt also stated that after the 1st reading of this bylaw, the road closure will be circulated to any affected parties and a Public Hearing will be held. Once all comments have been received from the affected parties and the Public Hearing is held, a road closure package will be sent to Alberta Transportation for approval before giving 2nd and 3rd Reading to Road Closure Bylaw.

A) Enforcement of Boulevard Parking

G. Birch stated that the Town's Police Service and bylaw enforcement personnel have prepared an information package showing the rules regulating parking on boulevards and examples of the numerous violations of these rules. The concern is that if they start to enforce the rules, there will be complaints. The issue was brought before the Traffic Committee (Councillor Prokop is the Council representative) and the decision was made to bring the matter before Council to raise awareness about it and seek Council guidance. At the very least, the Traffic Committee wants to raise awareness of the issue so that Council members are not caught off guard if they receive enforcement complaints.

MOVED by Councillor Strojwas that Council defers this item to the Development Authority (MPC) in collaboration with police forces to review the development permits for these locations and to come back to Council with a preset designated plan.

Mayor De Vlieger requested a friendly amendment to reflect a review of the guidelines prior to bringing this item back to Council.

TID directed the church to Administration, as the Town has an agreement with TID and bylaws are in place to be the only utility service provider. Therefore, in order for the Church to gain access to the TID line Council must approve their request.

Council discussed the expenses involved, Alberta Environment licensing, and amount of capacity requested.

C) Performing Arts Centre Business Plan Funding

G. Birch stated that at the January 25, 2016 meeting, Council resolved to accept the donation of approximately \$29,000 from the Arts Council of Taber to be used for future arts-related projects.

Mr. Birch also stated that an option would be for MNP LLP to create a Performing Arts Centre Business Plan that would support current and future grant applications as well as an indication of the viability of a Performing Arts Centre in Taber.

D) Encroachment Agreement - 5112 48 Ave

C. Armfelt provided details that the Taber IGA located on the subject property will be undergoing exterior renovations to update the facade of the building. The proposed development would include create an encroachment of 0.15 metres into the sidewalk on the front of the building. There would also be a canopy above the main doors creating an overhead encroachment of 0.76 metres.

According to the Encroachment Agreement Policy and Appendix A to Procedure #PLN-3 for encroachments into Town-owned Land and roads if the encroachment is greater than 0.3 meters the CAO will bring the matter to Council for their recommendation.

E) Solar Optix Analysis for possible projects on Town-owned buildings

G. Birch stated that the Town of Taber Council receives annual franchise fees from ATCO Gas and Fortis Alberta, and have assigned 7.5% of that annual fee revenue to be put towards the reduction of energy consumption in Town-owned buildings. The fund has now grown to a size that can be used. The Energy Conservation Committee's Terms of Reference outlines that they shall explore energy conservation projects for the Town and make recommendations to Council who then makes the final decision on projects to be implemented. The Energy Conservation Committee contacted Solar Optix to undertake an analysis of Town-owned buildings and properties to assess the best possible projects to reduce consumption.

Council discussed the project, efficiencies and potential savings.

The project was proposed as a celebration of Canada's 150th anniversary in 2017.

The Town was selected and held painting sessions through May 31 to June 2 for residents to paint the tiles for the mosaic. The completed tiles were combined to create a mosaic that represents Taber.

Council discussed the appropriate location for the mural to be placed.
