The purpose of the amendment is to update the funeral home definition to allow for a crematorium, amend the election signs to allow portable signs to be used, amend the portable sign section, to have a one year renewal time line instead of the present six months, and update the Residential Single and Two Dwelling District to allow Row Housing as a permitted use.

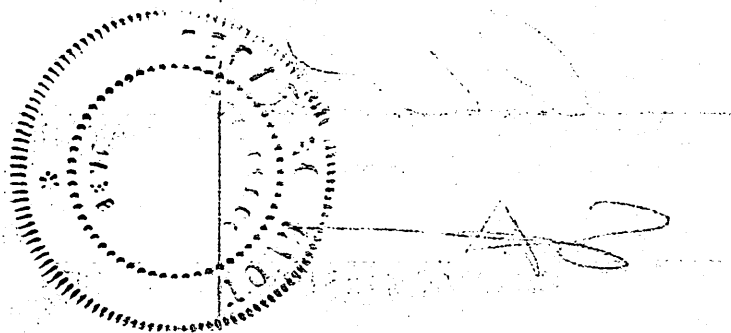
