LAND USE AMENDMENT BYLAW NO. 10-2017

i) Explanation of Purpose of Proposed Bylaw No. 10-2017

C. Armfelt introduced A. Malcolm, Director of Planning and Economic Development, who advised that Council at their Regular Meeting on May 8, 2017, requested Administration to review current Bylaws, policies, and procedures, in relation to the intended federal legalization of cannabis in 2018. He stated that upon review, Administration has determined the need to amend the Land Use Bylaw 14-2016 to provide clarity of interpretation of the bylaw prior to a future date when cannabis legalization is in effect.

LAND USE AMENDMENT BYLAW NO. 10-2017 – CONT'D

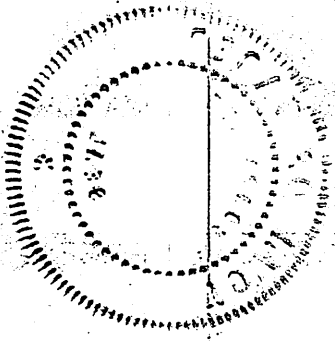
