achievements (though slightly out of date): Since ALERT was established in 2006, we have arrested more than 4,000 people and laid about 12,000 charges. During the 2010 – 2011 fiscal year, ALERT was responsible for taking \$115 million worth of drugs off the streets in Alberta. We laid 2,005 charges against 1,001 people. Throughout that same timeframe, ALERT seized nearly 30 kilograms of cocaine and 656 kilograms of marihuana, along with more than 100,000 marihuana plants. Our investigators also took 52 firearms off the streets as a result of targeted, organized crime investigations.

Key messages from ALERT about their current situation are as follows:

ALERT's position has not been to focus on any individual impact of funding reductions, as we maintain that cuts will negatively affect us universally. Granted, some business lines might be outright eliminated, the consequence of not expanding some teams to address caseload issue could be just as damaging.

- Over the past three years, funding for ALERT has been reduced by almost one third, or \$12.5 million. By next fiscal year, ALERT will be forced to cut more than 70 officers in order to address the projected budget shortfall. These are highly skilled officers, members of elite teams, spread across the province to protect our communities.
- ALERT expenditures significantly exceed grant funding and reserve funds have been depleted. Without a significant investment and financial commitment to ALERT, budget reductions in 2016-17 would threaten operations and existing teams.

- In consideration of budget reductions, ALERT has outlined a variety of risk factors that jeopardize ALERT's ability to deliver on its mandate and goal fulfillment. The risks are summarized as follows:
- o Reduced resources for organized crime teams undermines ability to conduct complex investigations involving surveillance, wire-taps, undercover operations, agents, etc.
- o Reduced capability to provide assistance, expertise, and skill set to partners for large-scale investigations, and to smaller communities;
- o Elimination of SCAN creates province-wide void in ability to enforce Alberta's problem properties legislation;
- o Failure to expand Internet Child Exploitation and Threat and Risk Assessment does not address increased demands for services.

#### Dear Minister Ganley:

As you know, the Alberta Association of Police Governance (AAPG) is an association of civilian police commissions, policing committees and associate members that represent the interests of the community on issues related to policing while providing governance and oversight to police services across the province.

Our role in policing in the province involves working with members and stakeholders to improve policing in Alberta. Many of our members sit on the Alberta Law Enforcement Response Teams (ALERT) board. We are kept up to date on ALERT's many achievements through our members, media reports and directly from ALERT.

We are writing to strongly support ALERT's continued presence in our province and encourage your government to provide sufficient and sustainable funding for ALERT's continued operation in Alberta.

ALERT keeps our communities safe through multi-jurisdictional operations and targeted enforcement activities. Organized crime and other criminal operations exist beyond boundaries in today's connected world. To effectively stop criminals from negatively impacting wide-reaching areas of our province, our police need cross-jurisdictional operations to pool intelligence gathering and other resources. This allows for real-time analysis and enforcement to shut down criminal activities. This approach goes well beyond sharing information to working cooperatively across boundaries and police organizations.

ALERT has many accomplishments that can be seen across the headlines in our newspapers. The essential work of ALERT's many teams cannot be overemphasized. The Combined Special Enforcement Unit makes almost daily arrests and drug and gun seizures, taking these dangerous items off our streets and, along with them, the individuals who put traffic in these items. The Safer Communities and Neighborhoods teams have a direct impact on the quality of life of Albertans by shutting down troubled properties so Albertans can live peacefully in their communities. The Integrated Child Exploitation unit rescues our most vulnerable, our children, from sexual exploitation. With guaranteed multi-year funding, these vital units will be able to accomplish even more to keep us secure and develop long-term goals and plans to ensure that our communities remain safe places to live.

Over the past three years, funding for ALERT has been reduced by almost one third, or \$12.5 million. By next fiscal year, ALERT will be forced to cut more than 70 officers in order to address the projected budget shortfall. ALERT expenditures significantly exceed grant funding and reserve funds have been depleted. Without a significant investment and financial commitment, ALERT 's operations and existing teams with be threatened. Specific risks to ALERT's ability to fulfill its mandate and goals include the following:

- Reduced resources for organized crime teams undermines the ability to conduct complex investigations involving surveillance, wire-taps, undercover operations, agents, etc.;
- Reduced resources reduce the capability to provide assistance, expertise, and skill set to partners for large-scale investigations and to smaller communities;
- Elimination of SCAN creates a province-wide void in the ability to enforce Alberta's problem properties legislation; and
- Failure to expand Internet Child Exploitation and Threat and Risk Assessment teams does not address the increased demand for services.

ALERT is vital to the ongoing safety and security of our communities. We hope you agree and implement sufficient and sustainable multi-year funding for this necessary organization.

The Alberta Association of Police Governance (AAPG) is an association of civilian police commissions and policing committees, as well as a variety of towns, protective services and highway patrol organizations, that represents the interests of the community on issues related to policing while providing governance and oversight to police services across the province.

At its 2014 Annual General Meeting, two resolutions were passed regarding equitable police funding in Alberta. Unfortunately, due to the change in Government, this ongoing issue has not yet been resolved.

As a member of the AAPG and as residents of Alberta, this issue is of great importance to the (insert organization name).

In 2010 the Government of Alberta released the Law Enforcement Framework (LEF). The vision of the LEF was that policing reflect the priorities of Albertans and, specific to the attached two resolutions:

The cost of policing services in Alberta should be shared in an equitable manner among Albertans and Alberta communities.

Strategic direction 9 of the LEF, calls for the development of a model to distribute the costs of local policing in an equitable, transparent and sustainable manner. This strategic direction highlights the need for

Shared responsibility for the costs of law enforcement services, whereby each municipality contributes to the costs of providing local policing.

Today, the Province is no closer to achieving the vision of this part of the LEF. As our representative in Alberta's Legislature, we call on you to complete the implementation of the LEF, in full, through the development and implementation of an equitable police funding model, whereby all Albertans pay for policing in the province with those funds returned in their entirety to policing in Alberta.

The additional funds that would come from an equitable funding model should be reinvested in policing. For instance, a portion of those new funds could be used to offset funding reductions to the Alberta Law Enforcement Response Teams and distributed to crime prevention and public safety strategies where it is most needed.

We are well aware that there are many views on what an equitable funding model would be, however, the time has come to fully discuss, debate and finalize such a model.

We look forward to your response about the action you are taking on this important issue.

# Alberta Association of Police Governance (AAPG) Annual General Meeting Drumheller, Alberta May 3,2014

#### POLICE FUNDING

**WHEREAS** the current legislation and level of support by the Government of Alberta creates substantial inequities in funding for police across the province; and

**WHEREAS** more than 20 percent of the provincial population receive policing through the Provincial Police Service Agreement at no direct cost; and

**WHEREAS** the average cost for policing in the 48 municipalities which are responsible for policing costs is approximately 15 percent of total tax revenue; and

**WHEREAS** in 2010 the Government of Alberta, through the Alberta Law Enforcement Framework (LEF), committed to restructuring funding for policing in Alberta to ensure it is a fair, shared responsibility "whereby each municipality contributes to the costs of providing local policing"; and

**WHEREAS** there has been no progress by the Government of Alberta in fulfilling its commitment pursuant to the LEF; and

**THEREFORE BE IT RESOLVED** that the Alberta Association of Police Governance reaffirm its 2011 resolution and again calls upon the Government of Alberta to fulfill its 2010 commitment to address the substantial inequities in funding for police across the province by developing the sustained, equitable and fair costing model envisioned in the Law Enforcement Framework; and

**THEREFORE ALSO BE IT RESOLVED** that any new funds obtained under a new costing model be reinvested into policing in Alberta (i.e. offset funding reductions to the Alberta Law Enforcement Response Teams).

#### **Equitable Funding**

**WHEREAS** The Alberta Solicitor General has established a Law Enforcement Framework; and.

WHEREAS Strategic Direction 9 calls for the development of a model to distribute the costs of local policing in an equitable, transparent and sustainable manner; and,

WHEREAS Alberta Communities of population less than 5,000 do not contribute directly to policing costs consisting of 234 municipal districts, towns and villages while the residents of 30 Alberta municipalities support local policing and are assisted through municipal policing assistance grants (MPAG); and,

WHEREAS The 234 Alberta entities which have no costs, nor receive MPAG assistance equates to having the 'first five free', five referring to the population and five referring to police officers at a ratio of 1:5T; and,

**WHEREAS** A practical cost per officer is \$100T.

#### THEREFORE BE IT RESOLVED THAT

The Alberta Association of Police Governance, in support of the Alberta Law Enforcement Framework Strategic Direction 9, calls upon Alberta Justice and Solicitor General to:

- a. Establish a police costing formula that would equally fund all Alberta communities, and
- b. That such costing formula reflects the advantage that exists in areas of less than 5T population.

#### **CASES OF INTEREST**

Police charged a Taber man after an investigation into a break and enter. On October 12, 2015, a local restaurant reported an entry and theft of the cash register and cash, security video was seized. Officers following instinct located CCTV from the previous day at another location and found a similarly dressed male who they were able to identify. The value of community policing in knowing Taber and the population led to solving this crime.

#### **PERSONNEL**

An ad has been placed for a constable position closing Nov 9. The departing officer last shift 15OCT28. Officer attends Use of Force Committee to finalize provincial guidelines to be recommended to the SG. Two officers attend Terrorism pre-incident indicator training provided by KINSET.

Officer attends open source intelligence gathering training – skills in on-line activities was explored. Inspector Abela participated in 3 weeks of training a group of Saudi Prosecutors in Victoria, instructing in interview techniques using Canadian police models.

#### **OPERATIONAL**

The SG has made recent inquiry regarding the use and practice of street checks. In Ontario the practice has been dubbed 'carding' and been the subject of much public and government inquiry as the activity is seen as racially motivated, in fact the Ontario Legislature is regulating the practice with a new law. The TPS response to the SG included our policy outlining the process. Persons coming to the attention of police are checked to determine their legitimacy under the circumstances, such as in a back alley at 4AM or some other suspicious activity. This is a lawful intelligence gathering process expected of officers on patrol. TPS does not support randomly stopping people on the streets, checks are evidence-led or in other words officers must be able to articulate their reasons for a check such as repeated citizen complaints about activity in certain areas. Street Checks are entered into the records system and are purged after two years.
