Chief Abela stated The Taber Police Service (TPS) Capital plan was created several years ago and the technology for a hand held speed detection systems, commonly known as a Laser, (actually LIDAR) has decreased. As a result, the Taber Police Service is able to purchase a LIDAR for about \$3200.00, however the Service was allocated \$8000.00. Also, there is a need to replace 4 microphones for the car video systems. Chief Abela stated that the department is able to purchase the 4 microphones and the LIDAR within the same \$8000.00 allotted to capital. As the microphones are a capital replacement, the authority of Council in needed to do this.
