 - 10) Machinery rescue to operations level;

	Moving forward there are a few areas in which we have identified within the service levels requiring review and adoption. These areas are:
Service Level / Staff Resource Implication:	Hazmat
•	Confined Space Rescue
	Medical First Responder
	Due to the risk of a hazardous material spill or leak within the town boundaries, and the amount of population which could be effected, increasing the training level and the resources for Hazmat is essential.
Justification:	With a growing number of confined spaces located with the manufacturing sector of Taber, having a confined space training and equipment could play a vital role in the event of a confined space incident.
	Due to the increase in the demand on the EMS system, and the eagerness of the firefighters, moving ahead on a Medical First Responder program allows



	our firefighters the opportunity to have advanced medical training which will allow they to be more effective when dealing with medical emergency. While keeping costs low as we can train in house.




