The undersigned has read and on behalf of the Community Event Organization agrees to be bound by this Agreement and the Terms and Conditions contained herein and attached hereto, and hereby warrants and represents that he/she executes this Agreement on behalf of the Community Event Organization and has sufficient power, authority and capacity to bind the Community Event Organization with his/her signature. The Community Event Organization agrees to inform all responsible officials associated with the organization of the Terms and Conditions in this Agreement.

Taber Emergency Services will provide ambulance service, subject to the following terms and conditions, in accordance with Town of Taber Council Resolution 175/10.

The Terms and Conditions of the Agreement are as follows:

- 1) Taber Emergency Services will provide its ambulance and crew for the hours required by the Community Event Organization, as stipulated in this Agreement.
- 2) The Town of Taber will provide two (2) ambulance personnel and one (1) ambulance for the requisite hours, subject to availability of personnel.
- 3) The Community Event Organization shall pay a fee for service, as follows:
 - Minimum of \$162.80 per hour for the first hour, and \$162.80 per hour for any portion of an hour over 20 minutes subsequently, for the provision of two (2) ambulance attendants, detailed as the Protective Services at Community Events crew. Times will be taken from the dispatch sheets logged at the Police Station.
 - > \$125.00 per day or any portion thereof, for provision of one (1) ambulance.
- 4) In the event that the scheduled time is exceeded, an additional fee of \$162.80 per hour will be applied.
- 5) Any transport of Event participants or officials from the Event will be billed at Alberta Health Services contract rates.
- 6) The Ambulance service retains the right to withdraw its ambulance from the Event if an emergency arises in the Town of Taber or M.D. of Taber, necessitating a full response of its resources. The Ambulance Service will do everything in its power to minimize any disruption to the Event.
- 7) In the event of cancellation, 96 hours (4 days) notification prior to the Event is required. Failure to provide adequate notification will result in a full payment of services scheduled.



- 8) All fees shall be made payable to the Town of Taber.
- 9) The Community Event Organization agrees that the Town shall not be liable or responsible in any way for any loss, damage, or injury to any property belonging to the Community Event Organization, or to any agent, employee, or invitee of the Community Event Organization.
- 10) The Community Event Organization agrees that the Town shall not be liable or responsible in any way for any personal injury or death that may be suffered or sustained by the Community Event Organization, or any agent, employee, or invitee of the Community Event Organization, or to any person that may enter into the Community Event areas.
- 11) The Community Event Organization agrees to indemnify and save harmless the Town from any and all liabilities, fines, suits, claims, demands, and actions of any kind or nature which may be brought against the Town, its agents or employees, arising out of the within Agreement.
- 12) The Community Event Organization agrees to ensure that the above indemnification of the Town shall survive the termination of the within Agreement.
- 13)The Community Event Organization must abide by all local By-Laws as well as Provincial and Federal laws, statues, etc.
