Related Procedure Name: Recognition of Service - Elected Officials and Board Members

1.0 **PURPOSE**

1.1 The Town of Taber wishes to acknowledge the commitment, dedication and service of Elected Officials and board members for their significant contribution to the community.

2.0 POLICY STATEMENT

- Council shall present a gift of appreciation at a regularly scheduled Council 2.1 meeting to elected officials and board members upon achieving significant milestones with the Town of Taber.
 - Council may choose to present a gift of appreciation for board members achieving significant milestones with the Town of Taber at a designated recognition event.
- 2.2 The following boards or committees shall include:
 - 2.2.1 Development Authority (Municipal Planning Commission)
 - 2.2.2 Taber Municipal Police Commission
 - 2.2.3 Municipal Library Board
 - 2.2.4 Taber Recreation Board
 - 2.2.5 Arts and Heritage Committee
- 2.3 Elected Officials shall be recognized for their service on a basis of 4 year terms.
- 24 Board members will be recognized for long term services to the community in three year increments. (3rd, 6th, 9th, 12th, 15th, 18th, 21st, 24th, etc.)



- 2.5 Elected officials will be recognized for all non-consecutive years of service.
- 2.6 Board members will be recognized for all consecutive years of service.
- 2.7 In the event retirement/resignation occurs between years listed above, Council may provide a gift of appreciation as they deem appropriate.
- 2.8 The recognition award will be an appropriate gift with the Town logo, distinguishing the years of service equal to \$30.00 per year of service for elected officials, \$20.00 per year of service for board members.
- 2.9 If an elected official or board member retires after 25 years of service, Council shall present a retirement gift based on \$50.00 per year of service and honoring the individual at an event, with the individual's input.
- 2.10 The recognition gift may be considered a taxable benefit in accordance with Canada Revenue Agency protocol.
- 2.11 Elected Officials and Board Members may contribute the value of their recognition gift as a donation in kind to a non-profit organization of their choice.
- 2.12 Administration shall establish procedures for this policy and shall be responsible to ensure the spirit and intent of the policy is adhered to.
