PROPOSED ROAD CLOSURE BYLAW NO. 18-2018

i) Explanation of Purpose of Proposed Bylaw No. 18-2018

P. Monks, Director of Planning and Economic Development, stated that the purpose of Road Closure Bylaw 18-2018 is to facilitate the development of lots in the Eureka Industrial Park along 62nd Street. She stated that 62nd Street is not being closed entirely, but instead the excess road right of way that was taken is being closed, and part of 66th Avenue is being closed as it will not be completed as a through road.

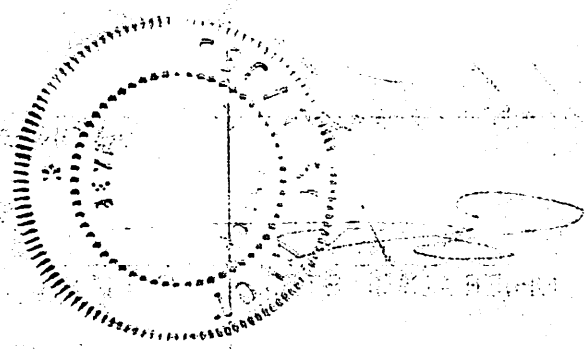
