
# Diesel Fuel Prices for industrial users holding steady

According to the Owl "Diesel fuel—the primary source of fuel used in the trucking and transportation sector—has risen and fallen in line the ever-fluctuating price of crude oil, the main input. The graph below shows the price index over the last five years for industrial users on the Prairies, with the price in 2010 set equal to an index of 100. The most recent price snapshot is for September 2017, with an index value of 102.4. Industrial diesel fuel prices are a mere 2.4 per cent higher than they were at the start of the decade. However, it hasn't always been so. Back in early2014, diesel fuel prices were nearly 60 per cent higher than in 2010, reflecting the fact that crude oil prices were also above \$US 100 per barrel for the benchmark West Texas Intermediate. Following the oil price decline over the subsequent two years, industrial diesel users saw the same price decline enjoyed by motorists filling up with regular refined gasoline. The diesel price index fell to as low as 75.1 at the beginning of 2016."
