Moved by R. Hadden that the Municipal Planning Commission approves a Temporary Development Permit 19-070 for a Food Truck to operate within the Town of Taber from 5104 46 Ave., Lot 1-5, Block 18, Plan 6390L for a period of six (6) months with the following conditions revised conditions:

- A) The development shall conform to the Food Truck requirements of the Town of Taber Land Use Bylaw 14-2016, and all applicable Provincial codes and regulations;
- B) The business shall conform to the Town of Taber Business License Bylaw 14-2018;
- C) A fire consultation must be had with the Town of Taber's Fire Department, and all applicable permits must be acquired prior to operation;

- D) The owner and/or operator must limit their hours of operation in any one location to a maximum of five (5) hours within a forty-eight (48) hour time period. Any one location is considered within 100m;
- E) If the Food Truck is not in operation for a period of five (5) days or longer it must be removed from the site.
- F) The owner and/or operator must have their own garbage receptacle;
- G) The owner may not dump any cooking oil or other substances into drains. Proper dumping shall be the responsibility of the Food Truck owner;
- H) Given the proximity of this location to a residential district, the owner and/operator must not cause any continuous sounds that exceed 65 decibels, and must not operate between 9pm and 9am;
- To further limit the impact on nearby residents, the Food Truck must be located within the northern 15 metres of the parcel;
- J) In addition to the food truck and required garbage receptacle, no additional structures or amenities shall be located on site:
- K) Must conform to the health standards of Alberta Health Services. Applicant shall contact Alberta Health Services for more information:
