Councillor Strojwas stated that it was brought to his attention that it was a ticket-able offence to have a "For Sale" sign in a vehicle that is parked in front of your property. He stated that Section 109(1) of the Use of Highway and Rules of the Road Regulation AR 304/2002 states that "a road authority may by bylaw or order authorize, subject to any terms of conditions that the road authority prescribes, the display of goods or the sale of goods on a highway under its direction, control and management".

Councillor Strojwas stated that he is requesting input from the Commission to recommend to Council to review Section 109(1), and to allow "For Sale" signs in vehicles as long as it does not obstruct the view.

The Commission discussed Section 109(1) provided by Councillor Strojwas.

Chief G. Abela noted that this portion of the legislation is in place to limit distractions that would result in a driver taking their eyesight off the roadway when operating a motor vehicle. He also stated that it limits potential issues with residents perpetually selling personal vehicles, as it can result in the roadway becoming a place of businesses.

The Commission further discussed Section 109(1) and the information provided by Chief G. Abela.

The Commission discussed bringing this item back to the Regular Meeting in September 2020.
